PrimeXBT Competition Terms and Conditions

1. Introduction

- 1.1. Participation in the PrimeXBT UEFA EURO 2024 price drawing competition (hereinafter referred to as the "Competition") is open to all eligible participants who adhere to the requirements specified below. This document outlines the official terms and conditions governing participation in the Competition (hereinafter referred to as the "Competition Terms").
- 1.2. Your participation in the Competition shall constitute your full and unequivocal acceptance of these terms, the PrimeXBT Terms & Conditions (Agreement) that govern the relationship between the Company and all of its Clients, and all relevant Policies (collectively referred to herein as the "**Terms**"), the latest versions of which are available at all times on the PrimeXBT Website (https://primexbt.com/), as may be amended from time to time.
- 1.3. The Competition Terms serve as a supplement to the Company's Agreement. Any and all terms and conditions included herein are effective and are to be read in conjunction with the Company's Agreement and any other policies available on the Company's Website. Any and all terms and conditions governing, inter alia, the offer, execution, conditions, prohibitions, termination, warranties, rights and restrictions for any products and services included in the Agreement, shall apply without any limitation to the Competition Terms. In the event of any discrepancy between the Competition Terms and the Agreement, the terms of the Agreement shall prevail.
- 1.4. The Competition Terms and all PrimeXBT products and services are not available to any person who resides in a restricted jurisdiction or to a US Reportable person as defined in the Company's Agreement. Please visit the Restricted Jurisdictions section on our website for more information.
- 1.5. The client acknowledges and agrees that the availability of certain products, platforms, and services may be restricted or unavailable in certain jurisdictions, subject to the Company's sole discretion. As of August 2, 2024, individuals accessing the Company's platform from within the Republic of Turkey shall be restricted from accessing global market products (Contracts for Difference (CFDs)), as well as copy trading services.

2. Eligibility

- 2.1. The Competition is void where prohibited by law.
- 2.2. Participants must meet all requirements outlined herein to be eligible for entry.
- 2.3. Participants must be natural persons with full legal capacity and over eighteen (18) years of age.

3. Competition Period

3.1 The Competition begins on July 8, 2024, and ends on July 14, 2024 (hereinafter refer to as the "Competition Period").

4. Entry Requirements

- 4.1. In order to enter the Competition, all conditions set below <u>must be fulfilled concurrently during the Competition</u> period:
 - 1. Successfully open a trading account (PrimeXBT account) with the Company; it should be noted that existing Clients who created an account with PrimeXBT before July 8, 2024, are still eligible to participate in the competition. However, they must meet the requirements set out below:
 - 2. Deposit a minimum of \$50 into your PrimeXBT account;
 - 3. Complete and submit the official giveaway entry form via the provided Google Form link to officially enter the Competition;
 - 4. Trade a minimum of \$1,000 on the Company's crypto futures in order to qualify for the draw;
 - 5. Predict the winner of the UEFA European Football Championship (UEFA EURO 2024);
 - 6. Follow PrimeXBT on social media.

5. Entry Limit

5.1 Only one entry per individual is permitted.

6. Prize

- 6.1. One winner will be awarded a \$2,000 trading credit (hereinafter refer to as the "Reward"). This Reward is non-withdrawable and must be used exclusively for trading on PrimeXBT. Any profits accumulated from trading with the Reward can be withdrawn.
- 6.2. The Reward is not transferable or exchangeable for cash.

7. Winner Selection

- 7.1. After the Competition Period ends, the winner will be determined by a random draw from all eligible entries received during the Competition Period.
- 7.2 The winner will be announced on the PrimeXBT blog and social media channels.
- 7.3. The reward will be distributed within 12 days after the end of the Competition Period.

8. Notification

8.1 The winner will be notified via the email address associated with his/her PrimeXBT account.

9. Legal Information

- 9.1 PrimeXBT reserves the right to modify, suspend, or terminate the Competition, the Competition Period and/or the Competition Terms at any time for any reason without prior notice.
- 9.2 PrimeXBT reserves the right to disqualify any participant who violates these terms and conditions or engages in any fraudulent or deceptive activity related to the Competition.
- 9.3 PrimeXBT's decisions regarding any aspect of the Competition, including but not limited to eligibility and winner selection, are final and binding on all participants.
- 9.4. PrimeXBT shall not be liable for any claims, costs, expenses, losses, damages, tax liability, or any other harm suffered by any participant or person as a result of engaging with the Competition. This includes, but is not limited to, any trading losses or loss of profit incurred during participation in the Competition, usage of trading credit, or any error, technical malfunction, or breakdown in the PrimeXBT Website, Trading Platform, or any related computer system, mobile application, downloadable software, or equipment, including that of the participant.

- 9.7. If PrimeXBT identifies that an individual is not eligible to participate in the Competition and receive the prize, PrimeXBT may at its discretion invalidate any entries or reverse and withdraw any trading credit awarded. No individual shall be entitled to any payment or compensation from PrimeXBT should any prize or corresponding profit be forfeited, canceled, or reclaimed.
