PrimeXBT Event Terms and Conditions

1. Introduction

- 1.1. Participation in the PrimeXBT Ethereum Birthday Celebration Event (hereinafter referred to as the "Event") is open to all eligible participants who adhere to the requirements specified below. - 1.2. 5. Entry Limit

5.1 Only one entry per individual is permitted.

6. Prize
