### PrimeXBT Reward Promotion Terms & Conditions

#### Introduction

These Reward Promotion Terms & Conditions, shall apply and govern the Reward Promotion (henceforth the "Promotion") offered to selected Clients (the "Client(s)", "you", "your") of PrimeXBT Trading Services Ltd, a company incorporated and existing under the laws of Saint Lucia, with Registration No. 2024-00343, having its registered office address at PKF Corporate Services Ltd., 1st Floor, Meridian Place, Choc Estate, Castries, Saint Lucia (hereinafter referred to as "**PrimeXBT**", the "Company", "we", "us", "our", as appropriate).

For the purposes of these terms, "selected Customers" shall be referred as Clients who do not reside in the European Union (EU) or banned countries, have not been previously banned as Clients, and are not suspected of prior promotional offer abuse.

Your participation in the Promotion shall equate to your full and unequivocal acceptance of these Reward Promotion Terms, the General Terms & Conditions of the Company, and all relevant Policies (collectively referred to herein as the "**Terms**"), the latest versions thereof being available at all times on the PrimeXBT Website, as amended from time to time.

#### Participation Eligibility

- 1. PrimeXBT offers its Clients the opportunity to receive a 5(five) το 500 (five hundred) USDT Deposit Reward.
- 2. To be eligible for the Promotion, clients must:
  - 2.1.1.Be successfully registered with a valid Client Account on the PrimeXBT trading platform by the end of July 7th, 2024,UTC time.

2.1.2. The Client Account must be in good standing.

3. Employees of PrimeXBT or any other company within the PrimeXBT group and their immediate family members are not eligible to participate in the Promotion, and are thus expressly excluded. Additionally, employees of any partners and agencies involved in the organization or conduct of the Promotion, as determined by PrimeXBT, are not eligible. The Promotion is also not open to employees of any other company engaged in direct competition with PrimeXBT.

The Promotion will be available for a limited duration, starting from the 11th of July 2024 and lasting until the 8th of August 2024 (henceforth the "**Promotion Period**").

#### Credit Reward

- 4. The Reward will be credited into the Client's Account and shall be reflected as a "Reward". For the purposes of these terms, the "Reward" shall be referred to as the "Credit Reward", the "Reward", or the "Credit" interchangeably.
- 5. The Reward credited to the Client's Account shall be available for use to open positions on the PrimeXBT Trading Platform for seven(7) days, from the day and time credited. After this period, the Reward will be deducted from the Client's Account and all positions solely depended on the Reward will be terminated.
- 6. The Reward can be lost but it cannot be exchanged.
- 7. Any profit derived from the investment of the credited Reward can be withdrawn by the Client.
- 8. If any restrictions apply to the Client's Account, the account will not qualify for a Reward until the restrictions have been lifted. The participating Client's Account must not be closed or suspended in order for a Reward to be credited to their relevant Wallet.
- 9. Trade fees, overnight financing charges and settled P&L shall not affect nor be deducted from the Reward amount and shall instead be charged or booked directly to your Margin Account Balance.
- 10. In the event that your Account Balance becomes negative due to trading loss or incurred fees through trading, you shall continue to be able to trade with the negative balance, as long as it does not exceed the Reward amount and your Client Account's Equity remains positive. - 12. PrimeXBT will not be liable for any losses that may be incurred as a result of trading, including trading with the Reward.

- 14. If PrimeXBT subsequently discovers that a participant is not eligible to participate in the Promotion, PrimeXBT may, at its discretion, reverse the Reward credit. No individual shall be entitled to any payment or compensation from PrimeXBT should any account credit be forfeited or reclaimed.

#### Limitations

- 21. PrimeXBT reserves the right to deny participation to the Promotion or terminate a Client's participation in the Promotion if it reasonably believes that there has been cooperation, collusion, or organization of trades and market manipulation, or if it reasonably believes that the Promotion is being abused in any way.

#### General Terms

- 22. By submitting their details and particulars to this Promotion, Clients consent to PrimeXBT using or sharing such information for Marketing efforts of PrimeXBT and/or its Partners or Sponsors. Participating Clients must inform PrimeXBT if they do not wish to receive such information by contacting PrimeXBT's Customer Service Team.
- 23. Clients acknowledge that PrimeXBT shall not be liable for any claims, costs, expenses, losses, or damages suffered by any person as a result of the Promotion and the Promotion Terms. Furthermore, PrimeXBT shall not be liable to any Client or any other person for any loss, tax liability, or damage arising in connection with the Promotion, including any error, technical malfunction of the World-Wide Web (internet) or the PrimeXBT Website or Trading Platform, or any breakdown or malfunctions in any computer system, mobile application, downloadable software, or equipment, including that of the Client.
- 24. The decision of PrimeXBT on all matters relating to the Promotion shall be final and binding on all participants. PrimeXBT reserves the right to cancel, revoke, or withdraw the Promotion and/or withdraw any credited rewards to any Client Wallet at any time and without the obligation to provide any reasons or explanations.
- 25. Clients acknowledge that PrimeXBT may, at any time in its sole and absolute discretion, without notice, terminate this Promotion, or delete, vary, supplement, amend, restrict, withdraw, or modify any one or more of the Terms in such manner as PrimeXBT shall think fit, including without limitation, the eligibility of any Client, the bases and methods of identification of participating Clients, and any dates in connection with the Promotion and the Promotion period.
- 26. Any dispute not covered by the Promotion Terms will be resolved by PrimeXBT in a manner it deems to be the fairest to all concerned, and that decision shall be final and/or binding on all parties.
- 27. These Terms are governed by the laws of Saint Lucia, and the Saint Lucia courts shall have exclusive jurisdiction over any matter or dispute arising from the Promotion and the Promotion Terms.
- 28. If any term of the Promotion Terms is found to be illegal, invalid, or unenforceable under any applicable law, such term shall, insofar as it is severable from the remaining terms, be deemed omitted.
- 29. If these Promotion Terms are translated into a language other than English, then the English version of the Promotion Terms shall prevail wherever any inconsistency arises.
- 30. These Terms and Conditions are subject to change at PrimeXBT's discretion, and its decision is final. PrimeXBT is the sole arbiter of these Promotion Terms and any other issue arising under this Promotion.
